On Monday 26th June 2023, he attended the West Sub Planning committee meeting. The consultation date for the intended changes to the A394 is likely to be announced in August 2023.

The inaugural meeting of the new Community Area Partnership is being held on Wednesday 28th June 2023.

Another meeting to discuss the possibility of re-opening Marazion Station with Ludgvan

parish and Marazion town councils, officers from Cornwall Council is to be held, date to be confirmed.

He will be speaking to Cornwall Council officers about the lack of a safety handrail and the height of the step up and down on the newly installed bridge over the Red River.

Reported that:

There are now enough volunteers to get the Speed Watch initivative off the ground. Next step, a meeting needs to be arranged with the volunteers to confirm their commitment towards the initiative and if all the volunteers are fully committed then Devon and Cornwall Police to be contacted to arrange training and formal formation of the Marazion Speed Watch team.

It has been reported that there are speeding vehicles coming into Marazion off the Goldstithney roundabout on the A394.

Residents of Warpsite Way have reported significant noise from high-speed motorbikes using the dual carriageway 7.30pm to 9.00pm.

Costings are still being sought for Speed Radar signs. Once the third quote has been received a report will be brought before the Full Council to consider.
