# 1730 Mayors Report/Matters of Urgency

#### The Town Mayor reported that:

On Saturday 15<sup>th</sup> July 2023 he attended a performance given by Cornwall Youth Choir in All Saints Church. The choir sang beautifully, and it was a joy to have attended.

He and Cllr Nicholas had spent time at the allotments removing abandoned carpet and other rubbish preparing the ground for new allotment tenants.

That the annual town walkabout held on Tuesday 18<sup>th</sup> July 2023 was useful. Thank you to all councillors and the Town Clerk for attending.

# a) Application PA23/01487

**Proposal** Partial demolition, reconstruction, and extension of an existing derelict workshop (Building 1) and the construction of a new shop (Building 2) **Location** Land And Garage South Of Silver Mine Market Place Marazion Cornwall .

**Applicant** Mr Marcus Price Silver Origins

**RESOLVED** – unanimous to object on the grounds: -

# With Building 1: -

Marazion Town Council would like clarification as to the working classification of the building and what its future use will be.

There are concerns over what environmental clean air measures have been taken and the sound levels that its use will create.

The Council are against the increase in size of the building, particularly the height, which will create overlooking, loss of light and loss of privacy for neighbouring properties.

The Council also believe that there is insufficient room to carry out safe vehicular movement in the area in front of the garages due to the addition of 4 extra parking spaces.

#### With Building 2: -

The ridge height of the proposed building should be stepped down more from the associated, existing building (Silver Origins) to clearly distinguish that it is a different building and to be more in keeping with the street scene.

Marazion Town Council would, in principle, support the development of a building on site 2 and the redevelopment of building 1. However, they do not support the proposal that has currently been submitted.

In conclusion the council object to the application on grounds of the overdevelopment of the garage (Building 1) creating loss of light and privacy for the

neighbouring properties, the addition of 4 extra parking spaces making vehicle manoeuvres unsafe and the ridge height (Building 2) being too high.
