1838 Public Participation.

A representative from the Marazion Museum gave a verbal presentation about the task of reopening this year for the first time since the pandemic and how successful the season has been. Key facts –

- 5000 visitors
- successes in recruiting a team of dedicated volunteers.
- free entry with donations. Donations and sales received has covered the initial reopening costs (the museum has been closed since 2020).

- Open four days a week, aiming to open five days a week in 2024 (subject to volunteers)
- offered specialised visits if requested and the team have helped with providing information for two historical books being published.

Cllr Laity proposed a motion for a letter to be sent to the Marazion Museum Trustees and volunteers thanking them for all that have achieved.

- the site visit with the Cornwall Council Highways Manager on Thursday 28th of September 2023 was helpful. St Levan Road and Close were visited, the Highways Manager made aware again of the continuing complaints being received, the lack of no waiting signage in North Street, the fading double yellow lines in and around the town.

1842 Councillors Reports.

a) Cornwall Councillor J Martin

Reported that:

Several people have contacted him about speeding on the Marazion bypass. Although a Devon and Cornwall Police and Cornwall Highways matter, his constituents are looking for some resolve to the problem. Cllr Martin went on to report that he has a meeting with the local Police Inspector very soon and will be raising the concerns of his constituents with the Police Inspector.

Cllr Laity asked if Cllr Martin can make mention of underage youths riding motorbikes, without helmets and at night, also the recent spate of anti-social behaviours with the smashing of residential windows and glass panels in the phone boxes.

He is hopeful to be able to attend the St Michaels Mount community annual meeting and upon the appointment of the new Chief Executive Officer. St Aubyn Estates, meet the new appointee.

He has meeting with Cornwall Councils Economic Growth Manager on Wednesday 18th October 2023, Marazion Town Hall. A working group has been formed to consider and review sustainable tourism so if any town councillor has any questions for the Economic Growth Manager, please let the Town Clerk know.

Other than an oversight in not ticking boxes 11a and 11b, confirming that the town council does not act as sole managing agent for trust funds, the external audit was completed successfully.
