1910 Public Participation.

PCSO Richards was invited to give an update to the Full Council about the recent spate of anti-social behaviours affecting the town. PSCO Richards encouraged the reporting of incidents as they happen and advised that in the case of mini motorbikes to dial 999 when these bikes are being ridden on the road without lights, helmets and by underage young people.

Cllr Collins thanked the PCSO for taking the time to attend and update the Full Council.

He and the Mayoress attended the Marazion in Bloom winners' presentation evening held on Monday 6th November 2023 in the Kings Arms. Cllr Collins praised the team at the Kings Arms for the hospitality shown to all those who attended the event.

The annual Marazion Wives Association Royal British Legion Poppy Appeal coffee morning was held on Wednesday 8th November which he attended showing support for such a worthy cause.

He along with Cllrs Nicholas and Tutchier had helped with the distribution of road signs for the Remembrance Sunday parade road closure. He had also sat in on the briefing given to all the volunteers who had offered to help steward the road closure on Sunday 12th November 2023.

Cllr Collins expressed his gratitude to the resident of Goldstithney who had not only assisted the Town Clerk with the event planning but had prepared all the necessary documentation for the road closure. Cllr Collins advised councillors that he would, using the Mayoral Allowance, purchase a £50 gift voucher to be used at the Cutty Sark as a way of saying 'thank you'. All councillors supported the suggestion.

Cllr Tutchier asked for letters of thank you can be sent to the volunteers. The Town Clerk confirmed that this was in hand.

The annual Remembrance Sunday commemorative service at the Marazion War Memorial was a success as was the Remembrance service held at the Marazion Methodist Church. Cllr Collins said 'thank you to Reverend Rebecca and Reverend Sophie for their support. Following the service, the representative from RNAS Culdrose, laid a wreath at the HMS Warspite memorial. Cllr Laity will contact the HMS Warspite Association to ask if they would like for a wreath to laid as a mark of respect on Remembrance Sunday.

Subsequently an e-mail had been sent to all known organisations asking for people to report anti-social behaviour to the Police and it is hoped that the local PSCO will be attending the next meeting of the Full Council.

Proposal: Partial demolition, reconstruction and extension of an existing derelict workshop (Building 1) and the construction of a new shop (Building 2)

Location: Land And Garage South Of Silver Mine Market Place Marazion Cornwall TR17 0AR

Applicant: Mr Marcus Price

RESOLVED – unanimously objected on the grounds that the town council have been presented with new evidence i.e., Title Plan CL 253299 which appears to show that the applicant is not in legal possession of all the land subject to this planning application. Therefore, this makes this application invalid, and a new application should be submitted showing the correct ownership.

Furthermore, the planning application form has been filled out incorrectly on page 7 under Trees and Hedges.

- 1.Are there trees or hedges on the proposed development site, where the applicant has stated No.
- 2. Are there trees or hedges on land adjacent to the proposed development site that could influence the development or might be important as part of the local landscape character, where the applicant has stated No. On 3844-PBWC-00-ZZ-DR-A-1002 REV P8 PL PROP SITE PLAN, it clearly states 'tree to be removed'. There is a tree in situ and is subject of the (incorrect) application which shows it on the applicant's land, or as it should be shown, adjacent to the applicant's land.

This is another reason why the application should be invalid, and a new application submitted.
