i Cllr R Stokoe

Reported that:

He continues to report potholes to Cornwall Council.

Cllr Stokoe asked the Town Clerk about the CiLCA training day and to remind the town council what the training is for and about. The Town Clerk will circulate the minutes approving the training.

ii Cllr P Hosking

Reported that:

The impact of recent rainfall has resulted in an increase in water running down Rosehill. A tree in the Memorial Garden requires remedial maintenance work following the storm. Cllr Read offered to help. Cllr Collins expressed his concern that the contractor engaged to carry out the works identified by the tree survey are not responding to telephone calls or e-mails.

She had fallen over a loose South West Water meter cover.

iii Cllr J Rawlins

Reported that:

There is a large pothole in the Folly Field car park. The Town Clerk will send an e-mail to St Aubyn Estates.

An increase in dog fouling has been reported in and around the Trevenner Square area of the town and that she has produced signs to be erected to encourage dog owners to pick up after their dogs.

A finger post sign to the Post Office remains in The Square. This sign is the property of Marazion Town Trust.

iv Cllr J Tutchier

Reported that:

He had a meeting with the Devon and Cornwall Police Speedwatch manager, and he had registered Marazion. Cllr Tutchier reported that he has completed all the documentation needed for himself and the next step is to arrange a meeting with the volunteers, get their documentation completed and submitted. Once complete Devon and Cornwall Police will come and train the Marazion Speedwatch group and help advise on locations for monitoring. In interim the Town Clerk will contact the Cornwall Council Highways Manager asking about locations for the speed radar signs.

v Clir P Read

There is a faulty streetlight in Chapel Street which needs reporting.

Old mine workings have become visible on the beach below Chymorvah. The Town Clerk reported that she has made the Duchy of Cornwall aware.
